



Official Approval of Company Name Change to “Tanabe Pharma”

Mitsubishi Tanabe Pharma Corporation (Head Office: Chuo-ku, Osaka; Representative Director, CEO: Akihisa Harada; hereinafter, “MTPC”) announced today that, pursuant to a resolution passed at the extraordinary general meeting of shareholders held today, it has officially decided to change its corporate name to “Tanabe Pharma Corporation”, effective December 1.

The new company name reflects MTPC’s commitment to further global growth as an R&D-driven pharmaceutical innovator, while honoring the legacy of the former Tanabe Seiyaku, one of the world’s oldest pharmaceutical companies. Aligned with this change, a total of 12 affiliated companies in Japan and overseas that are operating under the name “Mitsubishi Tanabe Pharma” will adopt the unified name “Tanabe Pharma” accordingly.

Even after the change of its company name, MTPC will remain guided by its mission of “Creating hope for all facing illness”, continuing to contribute to society through the research and development of innovative pharmaceutical products.
